

**RELEASE AND WAIVER OF LIABILITY AGREEMENT  
AND CONSENT TO EMERGENCY TREATMENT**

This agreement releases Frisco Community Bible Church, its employees, its congregation, or its agents (hereinafter collectively, "FCBC"), or any volunteered individual (hereinafter "Volunteer") from all liability relating to injuries that may occur to the undersigned (hereinafter "Participant") as a result of FCBC or Volunteers providing courtesy services to the Participant, including but not limited to transportation services, hospitality services, guide services, church sponsored services, and church related activities (collectively, the "Courtesy Services").

I expressly understand and acknowledge the risks involved in participating in Courtesy Services, including but not limited to traveling in motor vehicles in church related activities and/or to and from places as agreed by the Volunteer and the Participant. These further include but are not limited to the risk of loss or damage to personal property, the risk of sickness, personal injury, or death while participating in said Courtesy Services. I understand and agree that I am participating voluntarily, and that all risks have been made clear to me. Additionally, I do not have any conditions that will increase my likelihood of experiencing injuries while engaging in these activities.

It is expressly understood that all such potential losses, damage, injury, or death associated with my receipt of Courtesy Services are not known and cannot be determined as of the date of this Agreement, but it is the express intent of the Participant that this Agreement and assumption of risk apply to any and all such unknown damage, loss, injury, or death.

In consideration of the Courtesy Services that I have or will receive, I hereby waive and forfeit all right to bring a suit against FCBC and/or its insurance company and the Volunteer and/or his/her insurance company for any reason related to or arising from my receipt of the Courtesy Services. In return, I will receive Courtesy Services, including free rides in motor vehicles to and from FCBC and places as agreed by the Volunteer and the Participant. I will also make every effort to obey safety precautions as listed in writing and as explained to me verbally. I will ask for clarification when needed.

In consideration of the Courtesy Services that I have or will receive, I hereby give my consent for emergency medical and surgical treatment in a licensed hospital by a duly-licensed physician should my condition require it as related to or arising from my receipt of the Courtesy Services. As long as the medical or surgical treatment considered necessary in the situation is in accordance with generally accepted standards of medical practice for the particular type of

injury or illness involved, I impose no specific prohibitions regarding treatment unless stated specifically here below (if none, so state).

In consideration of the Courtesy Services that I have or will receive, I hereby release FCBC and the Volunteer from any legal claim arising from the administration of medication and the administration of emergency medical or surgical treatment as related to or arising from my receipt of the Courtesy Services. I also agree that I will be responsible financially for such emergency medical or surgical treatments.

In consideration of the Courtesy Services that I have or will receive, I hereby hold harmless FCBC and/or its insurance company, or the Volunteer and/or his/her insurance company, against any claims or liability, including financial responsibility for injuries incurred, regardless of whether the injuries to which FCBC or the Volunteer has no control or are caused by negligence, as related to or arising from my receipt of the Courtesy Services.
